A Home for Happy Children



Happy Home Orphanage is a non-profit organization located in Stella, a village in south-west Kenya about 400 kilometers from Nairobi.. Its founders include citizens of Kenya, Canada and Belgium.

The first group of children — 12 in all — arrived on November 2, 2006 . Since then, Happy Home has grown to accommodate 32 children with room for more.

Happy Home's mission is to help orphans and vulnerable children by providing them a nurturing family and home in which to grow. Each child receives access to safe shelter, good nutrition, health services and education.

Our vision is to help the children to grow up in their own culture within their own community and to keep contact with their extended families. To that end, we recruit staff from the area, send the children to a local school and encourage them to go on family visits for 1-2 weeks twice yearly during school holidays.

Happy Home exists thanks to a **large group of volunteers**, in Kenya and abroad. These include the **Board of Trustees**, **Donor Liaison Offices** in Kenya, Belgium, USA and Canada, and **volunteers** organizing fundraising activities or coming to Kenya to spend time with the children.

All received funds go directly to the home, to provide food, education, clothing, medical care and most important , caring staff acting as parents to the children.
